

**NOTICE OF PUBLIC HEARING ON
RATE INCREASES REQUESTED BY WASTE MANAGEMENT**

Maximum Rate Increase. The City of California City has received a request from Waste Management of California, Inc. (“Waste Management”) for an increase of the maximum rates Waste Management may charge its customers for waste collection related services. If approved, each maximum rate currently in effect would increase by up to 4.5% above the rates previously approved by the City, retroactive to July 1, 2018, as required by the existing Franchise Agreement between the City and Waste Management. For example, the maximum rate for weekly residential 35-gallon cart service would increase from \$12.89 to \$13.47 per month and the maximum rate for weekly residential 64-gallon cart service would increase from \$14.50 to \$15.15 per month. The amount of the request is based upon a formula in the franchise agreement which allows increases based upon changes to inflation, fuel costs and labor costs. Waste Management charges its fees only to customers to whom it provides services.

Hearing and Protests. At the date, time and place shown at the top of this notice, the City Council of California City will conduct a public hearing to consider the requested increase to the existing maximum rates. You are invited to provide oral or written testimony at the hearing regarding these matters. You may also submit to the City a written protest against the proposed maximum rates. Written protests may be submitted at the hearing or mailed to the City Clerk at 21000 Hacienda Blvd. California City, CA 93505, prior to the hearing. Protests may be submitted by the parcel owner or customer at any property served by Waste Management in California City. If, prior to the close of public testimony at the hearing, written protests are received with respect to a majority of parcels served, the City Council will not approve the proposal. Written protests must be signed by the owner or customer and must indicate the street address, parcel number, or account number for which the protest is made.
