Location: Strata Park Indoor Facility

Program Name: California City Indoor Soccer League (CCISL)

1. Executive Summary

The California City Indoor Soccer League (CCISL) is a proposed year-round indoor soccer program designed for youth and adult participants. The league will utilize the Strata Park indoor basketball/multi-use facility, which can be safely converted into an indoor soccer field. The program promotes physical fitness, teamwork, sportsmanship, and community engagement.

2. Purpose & Goals

- Provide organized indoor soccer opportunities for children, teens, and adults
- Offer a safe, climate-controlled environment year-round
- Promote healthy lifestyles and positive youth development
- Increase utilization of Strata Park facilities
- Establish a sustainable community sports program

3. Facility Use

The Strata Park indoor facility will be adapted with portable goals, temporary boundary markings, and futsal or indoor soccer balls. Existing lighting, seating, and restrooms will be utilized.

4. League Structure

Youth divisions (ages 5–17) and adult divisions (18+, 30+, and co-ed optional) will compete in 5v5 or 6v6 formats with 8–10 game seasons.

5. Schedule

Youth games will be held weekday evenings and Saturday mornings. Adult games will be scheduled during weekday evenings and weekends. Seasons will be offered year-round.

6. Equipment & Staffing

Equipment includes goals, balls, pinnies, cones, and first-aid kits. Staffing includes a league director, referees, coaches, and facility supervision.

7. Safety & Rules

No sliding tackles, shin guards required, proper indoor footwear, sportsmanship enforcement, and emergency procedures in place.

8. Awards & Recognition

First Place: Championship Trophy
Second Place: Finalist Recognition
Third & Fourth Place: Medals
Award ceremonies will be held at Strata Park.

9. Registration & Fees

Youth: \$75–\$120 per season
Adults: \$85–\$150 per season

Fees cover facility use, referees, equipment, administration, and insurance if required.

10. Marketing & Media

Promotion through local newspapers, city and park social media, league social media pages, flyers, and post-season media recognition.

11. Community Benefits

Provides safe recreation, promotes wellness, strengthens community ties, and maximizes use of city facilities.

12. Conclusion

The California City Indoor Soccer League will enhance Strata Park programming and provide lasting benefits to the community. Approval and support are respectfully requested.

SUBJECT: Kiln Installation at Strata

DISCUSSION:

Approximately 3 years ago, a Kiln (An oven that is used specifically for curing or drying clay once it has been shaped in order for the clay to harden, the finished product is better known as pottery) was donated to the Arts and Community Center's Arts Commission. Theresa Oaks was the Park and Recreation Supervisor at the time of donation. The Kiln installation was discussed between her and the Art Commissioners at that time. It was determined the Kiln would be installed at Strata Center in one of the offices. Upon inspection of the Strata Center, it made sense to use the corner office located at the NE side of the strata as it already has an electrical breaker box and would only require a new outlet to accommodate the kiln.

Since this determination, Theresa Oaks and the Art Commissioner(s) working on this project are no longer with the city. As such, Duane Vasquez, the current Art Commissions Vice President took on the project to have the kiln installed. As a result of the initial discussion, the City had purchased the materials needed to install the kiln in the corner office as referenced above. If this project goes forward, all the electrical work and the connection to the kiln will be completed in-house.

As the Park Coordinator, I believe this project should be discussed by the Park Commission to be able to move forward.

FISCAL IMPACT:

None- Purchases for the installation were previously made and there is no foreseeable future expenditure for this project.

RECOMMENDATION:

It is recommended that the Parks and Recreation Commission discuss the project, get the publics input, questions and/or concerns, then decide whether to bring the project to City Council for final approval and staff direction.
